Effective October 1, 2026

AgMarket also collects information about your transactions with us and our affiliates. We may use this information to open an account for you, process your requests and transactions, and provide you with additional information about our products and services. In order to service your account and mail correspondence to you, we provide your personal information to other independent firms that specialize in providing these services. These firms include our clearing firm(s), consulting firms, and our printing/mailing vendors. We require these other independent firms to protect the confidentiality of your information and to use the information only for the limited purpose for which the disclosure is made. We do not disclose any nonpublic personal information about our customers to other independent firms, organizations, or individuals except in furtherance of our business relationship with you, or as otherwise permitted or required by law. In addition, if you decide at some point to close your AgMarket account, we will continue to adhere to the privacy policies and practices described in this notice.

We restrict access to nonpublic personal information about you to those personnel who need to know that information to provide products or services to you. We maintain physical, electronic and procedural safeguards that comply with US federal standards to guard your personal information.
